



The BACW's Bidding Commission hereby present questions made by companies with their respective answers.

**REMARK:** The questions presented in this "Questions and Answers" shall be numbered as they are received by the Bidding Commission and may not match the numbering provided by the companies.

Therefore, the Bidding Commission has answered previous questions on November 6, 2017, November 8, 2017, November 10, 2017, November 13, 2017, November 22, 2017, and November 24, 2017. They are published on BACW's website.

**Question 44** – *About the republish of Invitation for Bid 173576 – Antennas, For BATCH #01, you will not buy in this Invitation for Bid?*

**Answer:** Since the minimum requirement of 3 proposals for BATCH #1 was achieved on the Open Session held at BACW on December 8, 2017 with its results registered in the Meeting Minutes 065/CPL/2017 sent to the accredited legal representatives of the participating bidders on the same day, only BATCH #2 of the solicitation was republished. The acquisition of BATCH 1 shall proceed in accordance with the procedures registered on the mentioned meeting minutes.

**Question 45** – *About the republish of Invitation for Bid 173576 – Antennas, I didn't see any price or specification change for the requirement of BATCH #02, that means all the requirement for BATCH #02 is the same as the last final version?*

**Answer:** That is correct, the requirements for BATCH #2 are exactly the same. The reason for the republishing is based on the fact that the solicitation for BATCH #2 did not achieved the minimum requirement of 3 proposals, as required in accordance with the bid announcement.

**Question 46** – *From now to Dec 18, that is an extremely short time to prepare all the new qualification and price proposal files, but we already provide the qualification and price proposal files to you on Nov 27. Is that possible for us to use those provided bidding files for this REPUBLISH OF Invitation?*

**Answer:** In accordance with item 4.5 of the REPUBLISHING OF INVITATION FOR BID 173576/CABW/2017,

*"4.5. Companies qualified in the INVITATION FOR BID 173576/CABW/2017 are not required to present new set documents and/or price proposals with its attachments.*

*4.5.1. Instead, the qualified bidder that desires to participate in the republishing of the Bid Announcement **must present, at the date of the open sessions described in this REPUBLISHING, a declaration stating the bidder's desire and allowing the Bidding Commission to consider the same documents presented in this solicitation.***

*4.5.1.1. The qualified bidders may also change its price proposal, present complimentary documents, and correct any mistakes."*

Moreover, in accordance with item 6.1 of the REPUBLISHING OF INVITATION FOR BID 173576/CABW/2017,



*6.1. Companies qualified in the INVITATION FOR BID 173576/CABW/2017 are not required to present new set documents and/or price proposals with its attachments.*

*6.1.1. Instead, the qualified bidder that desires to participate in the republishing of the Bid Announcement must present on envelope #1, at the date of the open session described in this REPUBLISHING, a **declaration stating the bidder's desire and allowing the Bidding Commission to consider the same documents presented in this solicitation.***

Finally, for the price proposal, in accordance with item 7.1 of the REPUBLISHING OF INVITATION FOR BID 173576/CABW/2017,

*7.1. Companies qualified in the INVITATION FOR BID 173576/CABW/2017 are not required to present new set documents and/or price proposals with its attachments.*

*7.1.1. The qualified bidders on Invitation for Bid 173576/CABW/2017 may also change its price proposal, present complimentary documents, and correct any mistakes. The set of alterations of the price proposal must be included in envelope #2.*

Notwithstanding, In accordance with the Republishing of the Invitation For Bid 173576/CABW/2017 item 25.1 "Any doubts arising from the provisions of this Invitation for Bid may be the subject of consultation, in writing, to the **Bidding Commission** in charge of this bidding process, up to 48 hours before the delivery of the proposals.

Based on that, the BACW's Bidding Commission reinforces that questions shall be submitted to [con@cabw.org](mailto:con@cabw.org) and no agents outside BACW should be copied in the e-mail. Thus, only answers published in BACW's website are considered official and part of the solicitation file.

Furthermore, the Brazilian Aeronautical Commission appreciates the question, and stands available to clarify and explain any doubts or concerns in order to increase the BID quality. Any questions or concerns must be submitted to **con@cabw.org**
